INTRODUCTION:

This quarterly information report provides an update to the Edmonton Police Commission on the Edmonton Police Service's authorized full time equivalencies versus actual full time equivalencies for the time period of 2018 January 01 to 2018 June 30 inclusive.

COMMENTS/DISCUSSION:

As of 2018 June 30, we were over authorized strength by 39.41 sworn member FTE's. We were over authorized strength by 17.13 civilian members FTE's for a total of 55.54 FTE's over authorized strength.

Included in the above sworn numbers are the 41 recruits and pre-hires that have not gone out onto the street.
