SUBJECT: Review Table of Rewards

RECOMMENDATION(S):

That the Edmonton Police Commission (EPC) approves the following recommendations:

- ♦ Renew thirteen (13) rewards set to expire or have expired in 2019.
- Remove two (2) rewards as they no longer meet the criteria for the Reward Program.
- All rewards are to be updated annually in April of each year.

INTRODUCTION:

This report will provide information and present recommendations for action and update to the EPC on the rewards for unsolved homicides and an arson investigation. Rewards are scheduled for renewal every three years. All rewards are up to \$40000.00 unless specified.

BACKGROUND:

At present there are thirty-seven (37) outstanding rewards posted for Homicide and one (1) outstanding reward posted for Arson. Of these rewards, thirteen (13) homicide rewards have or are scheduled to expire in 2019. Two (2) homicide rewards, one set to expire in 2019 and the other to expire in 2020, no longer meet the criteria for the Rewards Program and therefore, we are requesting consideration they be removed. No new rewards are being forwarded for consideration in 2019.

COMMENTS/DISCUSSION:

The rewards scheduled for renewal are:

1. 04-2756 HUSSAIN, Mir

On 2004 Jan 03 police were called to a stabbing in the area of 121 Street and Stony Plain Road. Police learned that Mir HUSSAIN had been in the driver's seat of his car, stopped at the light at 121 Street and Stony Plain Road, when he was approached by a male from a car behind him. Mir HUSSAIN exited the vehicle and was fatally stabbed by a second male during an altercation.

2. 04-63992 BLACK aka FORD, Cheryl expiry: 2019 Oct 20

On 2004 May 18 police received a report of a body inside a burned out dumpster behind 10322-83 Avenue. The victim was identified as Cheryl BLACK.

3. 06-21835 ABDALLA, Omar Mohammad expired: 2019 Mar 17

On 2006 Feb 12 police were called to a shooting at #9, 10823-115 Street. ABDALLA had been shot and three male suspects fled the scene.

4. 07-066268 BULGAK, Deng expired: 2019 Mar 17

On 2007 May 15 gunshots were reported in the area of 133 Avenue and 82 Street. Police responded and found a vehicle stopped in the alley at the rear of 13331-82 Street. BULAK was found deceased in the backyard of 13329-82 Street; he had been shot. A second victim, Juk RING was found deceased in the driver's seat of the vehicle. He had also been shot.

5. 07-066368 RING, Juk expired: 2019 Mar 17

On 2007 May 15 gunshots were reported in the area of 133 Avenue and 82 Street. Police responded and found a vehicle stopped in the alley at the rear of 13331-82 Street. RING was found deceased in the driver's seat; he had been shot. A second victim, Deng BULGAK was found deceased in the backyard of 13329-82 Street. He had also been shot.

6. 07-126742 HASSAN, Farhan expired: 2019 Mar 17

On 2007 Sep 02, police responded to Fulton Place Community hall at 6115-Fulton Road after a report of several gunshots. Farhan HASSAN and Kasim MOHAMED had been shot and killed. The suspects had fled the scene

7. 07-126742 MOHAMED, Kasim expired: 2019 Mar 17

On 2007 Sep 02, police responded to Fulton Place Community hall at 6115-Fulton Road after a report of several gunshots. Kasim MOHAMED and Farhan HASSAN had been shot and killed. The suspects had fled the scene.

8. 08-122002 SAID, Nasir

On 2008 Sep 16 Nasir SAID was found deceased at the rear of Balwin School located at 7055-132 Avenue. SAID had been shot.

9. 08-143165 ABUKAR, Abas

On 2008 Oct 31 Abas ABUKAR was discovered by a passer-by in Northmount Park at 9208-140 Avenue. ABUKAR was deceased and had been shot.

10. 08-158203 MOHAMOUD, Abdul

On 2008 Dec 02 police responded to several reports of gunshots heard in the area of 109 Street and 130 Avenue, Grand Trunk Park. A small white vehicle was observed speeding away from the scene. Later, Abdul MOHAMOUD was found deceased lying under a tree in the park. He had been shot.

11. 08-158598 ABDIRAHMAN, Ahmed

On 2008 Dec 02, police received numerous calls of gunshots fired in the area of 148 Avenue and 90 Street. Upon police arrival they found ABDIRAHMAN lying in a common area of the condo complex located at 14814-89 A Street. He had been shot and was deceased.

12. 09-154943 ISSE, Abdulaziz

On 2009 Nov 11 Abdulaziz ISSE was found deceased lying face down in the grass on the south side of the Beth Israel Synagogue located at 131 Wolf Willow Road. Located near a ravine. ISSE had suffered severe blunt force trauma.

13. 09-162940 MOHAMED, Robleh

On 2009 Nov 29 police responded to a report of gunshots in the area of 105 Street and 106 Avenue. Upon arrival they found MOHAMED deceased in a vehicle which was parked behind 10610-105 Street.

14. 04-149719 NGUYEN, Huy Le

Reward not to be renewed

On 2004 Nov 20 Police were called to a shooting outside the Noodle House restaurant located at 5620 Calgary Trail. Huy NGUYEN had just left the restaurant when he stopped and talked to a group of friends. A vehicle approached the group and several shots were fired, hitting four victims. Huy NGUYEN died while the other three victims were transported to hospital and survived.

The file has been reviewed and no longer meets the criteria to be considered for inclusion in the Reward Program.

15. 03-62274 SAGONIUK, Samuel

Reward to be removed

On 2003 May 23 police and paramedics responded to the residence at #2, 10434-95 Street. Samuel SAGONIUK was discovered deceased lying on the floor suffering from multiple stab wounds.

Reward set to expire in 2020; request consideration be given to remove it from the Rewards List as it no longer meets the criteria for the Rewards Program.

CONCLUSION:

Although these fifteen (15) homicide rewards listed remain unsolved, we are respectfully requesting thirteen (13) rewards be renewed as two current (2) homicide rewards no longer meet the requirements for inclusion. It is hoped the posting of rewards will solicit information to advance the investigations.
