SUBJECT: Edmonton Police Service Control Tactics Statistics

2021 January - December Report

RECOMMENDATION:

That this report be received for information.

INTRODUCTION:

The Edmonton Police Service (EPS) submits two reports annually to the Edmonton Police Commission that outline all instances of reported use of force. One report provides a statistical summary of use of force events that occurred during the first half of the year and the second report provides a statistical summary of the entire year.

The information contained in this report was generated using statistical data captured from electronic Control Tactics Reports for occurrences with reported dates between 2021 Jan 01 and 2021 Dec 31. This report will also include a comparison of the current use of force data with previous data.

EPS Critical Operational Risk and Ethical (CORE) Evaluation Initiative

Canadian Police Services may very well be facing one of our greatest challenges as we all have witnessed the sentiments of public opinion advancing unfavorably throughout North America in the question and debate on the legitimacy of Police and our role in our communities. The year 2020 was certainly a year of perspective in this regard. It was also a year of opportunity and poses an important question that should be asked, and was.

What have we done since?

In early 2021, the EPS Chief's Committee approved the CORE Evaluation Initiative. The purpose and objective were to, "Maintain Community Trust and Acceptance through innovative leadership, accountability, and managed performance, driven by Ethical Evaluation of identified Critical Operational Risk." This inititave was presented to the Edmonton Police Commission (EPC) in the spring of 2021.

During the course of the 2021, CORE Training Section provided the EPS membership with on-going comprehensive training relative to use of force accountability. The training objectives emphasied:

- 1. Completeness of the information in use of force report's and events (Control Tactics reports);
- 2. Examine each event for consistent information, plain language articulation for the legal basis for the Police action and to ensure information in the reports are authentic or correct;
- 3. A review to determine if the Police action was appropriate, legal, and in conformance with Service policy and procedure; and,
- 4. Evaluate the supervisory (Chain of Command) oversight of the event and any post-incident review.

Note: The CORE Evaluation Initiative and subsequent training to ensure accountability and managed performance is likey a driving factor in the increase of Control Tactics Reports that will be discussed within this report.

BACKGROUND:

The EPS captures use of force data through its electronic Control Tactics Reports. Control Tactics Reports are submitted after a police officer utilizes force where one or more of the following circumstances are present:

- 1. Injury resulting to any person;
- 2. Force used was higher than empty hand (soft) control, which is used for cooperative handcuffing;
- Use of control tactics such as stunning techniques, direct mechanical techniques, chemical agents (O.C. spray), conducted energy weapon (CEW), control instruments, impact weapons, special impact munitions;
- 4. Firearm was drawn, displayed or pointed;
- 5. In the opinion of the investigating member and/or supervisor, unusual circumstances exist that necessitate the submission of the report.

COMMENTS/DISCUSSION:

There were 3179 control tactics occurrences in 2021, 18.9% higher than 2020. There were 5772 control tactics forms submitted in 2021 as compared to 4546 in 2020, an increase of 27.0%.

The reason that the number of Control Tactics Reports (in the chart below) are higher than the number of occurrences is due to the EPS policy requirement for every officer, involved in a use of force, to submit a Control Tactics Report.

The Edmontron Police Service has two broad Use of Force categories. Generally, Category I reviews involve reportable uses of force of a minor nature and Category II reviews are those involving a higher level, or those circumstances where a supervisor decides a Category II review may be warranted.

Note: The data from incidents that require a 46.1 notification to the Director of Law Enforcement, which get assigned to the Alberta Serious Incident Response Team (ASIRT), do not form part of this report.

The two previous tables show that the majority of Occurrences are Category I occurrences which consist of displays of force, (CEW Presence or Firearms Low Ready) and the lowest levels of hands on control such as holding/escort positions and joint locks. They also show that 64.8% of Control Tactics Reports in 2021 did not rise above the threshold for a Category I review.

A very important consideration for perspective is that the EPS created a total of 377,049 events in 2021 which resulted in some form of community interaction. Of those events, 231,718 included a police file or report of which 3,179 resulted in a reportable Control Tactics or Use of Force action.

The ratio of control tactics/use of force occurrences to events was 0.84%.

CONCLUSION:

In early December 2020, CORE Training Section (formally Training Section) initiated an assessment and review of the ROR and use of force training program for both Recruit and in-Service members. The purpose of the review was to ensure that the standards for the program were highly defensible and support the overall development of core skills to mitigate risk when engaging critical operational events.

The objective was to ensure that the EPS ROR training program provides our members the core skills and ability to achieve the highest professional and ethical standards and to support and maintain community trust. As previously stated, the CORE training program must embrace an organizational philosophy that is not only conceptually and theoretically sound but supports operationally the way of doing business with the highest of ethical standards and conduct.

This initiative is a risk mitigation framework and process to support leadership and growth of individuals and teams and to maintain Community Trust through a defensible and comprehensive program that provides appropriate oversight and review of critical operational risk events.

The CORE Evaluation and ROR Initiative establishes a means of governance and a systematic and disciplined approach to evaluate and improve the effectiveness of Critical Operational Risk and to ensure Ethical Evaluation. This initiative strongly supports pre-incident preparation of anticipated Operational Risk, emphasizes post incident review to address performance management and preventative actions, and to establish timely and effective recommendations moving forward.



[&]quot;Firearm" encoumpasses the following Police issued firearms: Handguns, Carbines, Shotguns, Rifles, and Tactical Firearms.


[&]quot;Occurrences" refers to one specific situation where officers responded and utilized their firearm in one of the following methods: low ready position, pointed or fired.






"CEW" refers to the TASER X26 the current model that the Edmonton Police Service issues: CEW is classified as an Intermediate Weapon




[&]quot;Presence/Laser" refers to when the CEW is removed from the holster and displayed either by mere presence, or with the laser sight activated and pointed at a subject (no actual deployment of the weapon occurs in this fashion).

"Probes" refers to when 2 barbed probes are discharged from the CEW cartridge at a suspect.



[&]quot;Stun" refers to when the CEW is deployed directly against the subject as a pain compliance technique.


This also encompasses a situation where there may be more than one deployment (ie. Presence is ineffective, with Probes subsequently deployed).



Control Tactics Report Process

2021 (January through December)

EPS total Created Events = 377,049 of which include:

Events with File Number = 231,718

Events with Control Tactics / Use of Force = 3,179

Percentage of total created events resulting in control tactics/use of force = 0.84%

There were 1447 control tactics occurrences in 2021, 9.3% higher than 2020. There were 2572 control tactics forms submitted in 2021 as compared to 2258 in 2020, an increase of 13.9%.
