# REPORT TO THE EDMONTON POLICE COMMISSION

**Annual Table of Rewards Update and Rewards Renewal** 

#### **RECOMMENDATION(S):**

The Edmonton Police Commission (EPC) approves the following recommendations:

- 1. Renew all 13 rewards set to expire in April, 2022 and approve 1 additional file for a reward.
- 2. Approve the table of rewards (attached).

#### **BACKGROUND:**

At present there are 30 outstanding rewards posted for Homicide. Of these rewards, 13 homicide rewards are scheduled to expire in 2022. Upon review of the 13 rewards, it is requested that all 13 rewards be extended for three years. 1 new reward is being forwarded for consideration in 2022.

#### **COMMENTS/DISCUSSION:**

The rewards recommended for renewal are:

- 1. 04-2756 Mir HUSSAIN expires: 2022 April 18
  On 2004 January 03, police were called to a stabbing in the area of 121 Street and Stony Plain Road. Police learned that Mir HUSSAIN had been in the driver's seat of his car, stopped at the light at 121 Street and Stony Plain Road, when he was approached by a male from a car behind him. Mir HUSSAIN exited the vehicle and was fatally stabbed by a second male during an altercation.
  - 2. 04-63992 Cheryl FORD, aka BLACK expires: 2022 April 18
    On 2004 May 18, police received a report of a body inside a burned-out dumpster behind 10322-83 Avenue. The victim was identified as Cheryl BLACK.
  - 3. 06-21835 Omar/Mohammad ABDALLA expires: 2022 April 18
    On 2006 February 12, police were called to a shooting at #9,10823-115 Street.
    ABDALLA had been shot and three male suspects fled the scene. ABDALLA died of his injuries.

- 4. 07-066268 Deng BULGAK expires: 2022 April 18
  On 2007 May 15, gunshots were reported in the area of 133 Avenue and 82 Street.
  Police responded and found a vehicle in the alley at the rear of 13331-82 Street.
  BULGAK was found deceased in the backyard of 13329-82 Street; he had been shot.
  A second victim, Juk RING, was found deceased in the driver's seat of the vehicle.
  He had also been shot.
- 5. 07-066268 Juk RING expires: 2022 April 18
  On 2007 May 15, gunshots were reported in the area of 133 Avenue and 82 Street.
  Police responded and found a vehicle in the alley at the rear of 13331-82 Street.
  RING was found deceased in the driver's seat; he had been shot. A second victim,
  Deng BULGAK, was found deceased in the backyard of 13329-82 Street. He had
  also been shot.
- 6. 07-126742 Farhan HASSAN expires: 2022 April 18
  On 2007 September 02, police responded to Fulton Place Community hall at 6115Fulton Road after a report of several gunshots. Farhan HASSAN and Kasim MOHAMED had been shot and killed. The suspects had fled the scene.
- 7. 07-126742 Kasim MOHAMED expires: 2022 April 18
  On 2007 September 02, police responded to Fulton Place Community hall at 6115Fulton Road after a report of several gunshots. Kasim MOHAMED and Farhan
  HASSAN had been shot and killed. The suspects had fled the scene.
- 8. 08-122002 Nasir SAID expires: 2022 April 18
  On 2008 September 16, Nasir SAID was found deceased at the rear of Balwin School located at 7055-132 Avenue. SAID had been shot.
- 9. 08-143165 Abas ABUKAR expires: 2022 April 18
  On 2008 October 31, Abas ABUKAR was discovered by a passerby in Northmount Park at 9208-140 Avenue. ABUKAR was deceased and had been shot.
- 10. 08-158203 Abdul MOHAMOUD expires: 2022 April 18
  On 2008 December 02, police responded to reports of gunshots heard in the area of Grand Trunk Park at 109 Street and 130 Avenue. A small white vehicle was observed speeding away from the scene. Later, Abdul MOHAMOUD was found deceased lying under a tree in the park. He had been shot.
- 11. 08-158598 Ahmed ABDIRAHMAN expires: 2022 April 18
  On 2008 December 02, police received numerous calls of gunshots in the area of 148 Avenue and 90 Street. Upon police arrival they found ABDIRAHMAN lying in a common area of the multi-unit residence located at 14814-89A Street. ABDIRAHMAN had been shot and was deceased.
- 12. 09-154943 Abdulaziz ISSE expires: 2022 April 18
  On 2009 November 11, Abdulaziz ISSE was found deceased lying face down in the grass on the south side of the Beth Israel Synagogue located near a ravine in the area of 131 Wolf Willow Road. ISSE had been shot.

13. 09-162940 Robleh MOHAMED expires: 2022 April 18

On 2009 November 29 police responded to a report of gunshots in the area of 105 Street and 106 Avenue. Upon arrival they found MOHAMED deceased in a vehicle which was parked behind 10610-105 Street. He had been shot.

#### **New Request**

14. 12-40411 Chad SWANSON New Request

On 2021 March 29, police were notified of a possible deceased person sitting in a vehicle parked in the area of 167 Avenue and 113 Street. Upon police arrival a deceased male was discovered in the driver's seat with a fatal wound. The male was later identified as Chad SWANSON. He had been shot.

#### **CONCLUSION:**

We are respectfully requesting thirteen rewards be renewed, and the addition of one new reward. It is hoped the posting of rewards will solicit information to advance the investigations. As noted in the attached table, rewards may vary and be up to the maximum noted amount.
