SUBJECT:

Re-Zoning of Downtown Division Beat Boundaries

RECOMMENDATION(S):

That this report be received for information.

- Creation of a new Beat district (Cromdale) with boundaries covering Cromdale/Boyle Street (Stadium Road to Jasper Ave / 95 ST to 82 ST)
- Creation of a new Beat district (Oliver) with boundaries covering (121 ST to 116 ST / 100 AVE to 105 AVE)
- Creation of a new Beat district (Jasper West) with boundaries covering Jasper Avenue West (105 ST to 112 ST / 100 AVE to 102 AVE)

INTRODUCTION:

This report will provide information, for the EPC on the re-zoning of Downtown Division Beat Boundaries.

BACKGROUND:

In Q4 of 2022, the Healthy Streets Operation Center (HSOC) was approved for implementation into the downtown core - specifically within the Boyle and Centre beats districts - after a pilot project, "Project Connection," was successful. HSOC creation was the result of dramatic crime and disorder in the area, compounded by violent offences and the overwhelming number of community members experiencing houselessness and vulnerability within these boundaries.

HSOC encompasses a large area of three existing geographical DT Beats (specifically Boyle, McCauley Quarters, and the City Centre beats). This overlap can create some confusion regarding assignments and responsibilities. HSOC has a current staffing level of 2 Sergeants and 16 Constables with an anticipated staffing level of 4 Sergeants and 32 constables in Q1 of 2024. At present, Downtown Beats staffs these areas with two members per beat team. In contrast, HSOC is partnered with multiple resources such

as AHS paramedic, CPO, EFD (2023 anticipation) and are much better equipped to triage Community members with complex needs.

This prompted a conversation on leveraging current Beat resources in different high crime and disorder areas within Downtown Branch. An analytical review was undertaken to determine what those locations were to ensure resourcing was going into the appropriate areas. EPS Business Analytics, Intelligence & Reporting Section (BAIR) undertook this analysis and determined that the Cromdale, Jasper West, and Oliver area's are experiencing high volumes of violent crime, social disorder, and property crime with a combined occurrence total of 5525 in a one-year period (October 1, 2021-October 31, 2022). Within this time period, Oliver had 1757 calls for service, Cromdale 2403, and Jasper West 1564 respectively. This was significantly higher than any other geographies in Downtown Branch.

Based on the statistical data, the proposed new Beat geographies within Downtown will benefit from having a dedicated 'Beat' which is expected to have a dramatic impact on further gaining public support and reducing crime and disorder.

Another advantage of pivoting the current noted Beat geographies is HSOC and Downtown Beats will have; a clear delineation of assignments and work areas of responsibilities creating better accountability for both sections, avoid a duplication of work, provide clear lines of contact and communication between members and stakeholders, increase job satisfaction for members, and substantially decreasing the need for deconfliction of targets/projects which is often cumbersome.

COMMENTS / DISCUSSION:

- 1. When reviewing the HSOC boundaries it was noted that there was significant overlap with existing Downtown Beat boundaries. Due to HSOC teams being comprised of the appropriate multi-disciplinary partnerships and staffing levels to best serve the communities within their area of responsibility, Downtown Beats proposed that the existing beat boundaries be revisited.
- 2. A divisional analytical review was conducted to identify areas which would benefit most from the Beat program while proactively supporting the anticipated displacement of community members which may occur due to HSOC's presence. During the requested analytical review, a large volume of calls for service were identified in proximity to the current HSOC boundaries. The communities of Oliver, Cromdale / Boyle Street, and Jasper Avenue West had the highest concentration of violent crime, social disorder, and property crime of the areas that were evaluated.
- 3. Creation of Beat districts in the above-listed areas would provide ownership and dedicated Beat services to the affected communities. In addition to the 3 proposed new Beat districts, Downtown Beats would also retain the two existing Beat districts of 107 Ave McDougal (106 AVE to 108 AVE / 101 ST to 109 ST) and Jasper Avenue East (100 AVE to 102 AVE / 97 St to 105 ST).

- 4. If these proposed new Beat district boundaries are approved, Downtown Beats and HSOC will identify a two-week transition window where the two areas will work collaboratively to facilitate a proper knowledge transfer and to ensure that HSOC is introduced to all area stakeholders.
- 5. No additional staffing would be required, the existing 12 members would pivot from their current geographies into the three new noted geographies.
- 6. If approved, IT will be required to input new geographies into CAD. HSOC CAD boundaries would be completed at the same time.


